

Privacy policy

This privacy statement covers all aspects of the Aristion Academy website. Please read it carefully before accessing the site.

Information collection

Aristion Academy is the sole owner of the information collected on the site. We may collect information from our users, as these are defined in our main Terms and Conditions, at several different points on the site.

Aristion Academy takes all necessary precautions to ensure that the personal information of our users, including credit card information, is kept confidential. Your credit card information is protected during transmission over the internet by encryption using Secure Sockets Layer (SSL) protocol. Such credit card information is not held by us but may be held by [PayPal](#) depending on which payment provider processes the transaction.

Why do we collect and use personal data?

We might process personal data related to the users of our website. We gather the personal data to facilitate with the provision of our services.

We collect and use personal data under the following lawful bases:

- where we have consent by the data subject;
- where necessary to execute a contract with the data subject;
- where it is necessary for compliance with a legal obligation;
- where processing is necessary to protect the vital interests of the data subject or of another person;
- where it is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller
- where justified by the legitimate interest of Aristion Academy or of the data subject's legitimate interest or other's.

The information that we collect, hold and share may include:

We hold personal data about Users to provide our services.

The abovementioned data may include but is not restricted to basic details such as name, address, date of birth, phone number.

How long are general data retained?

We retain personal data for the period necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required by law. For more information about the retention period of specific data please contact us.

Who do we share personal data with?

We will not share information about the data subject with anyone without a contractual legal basis and unless the law and our policies allow us to do so.

We do not transfer personal data to third countries or other organizations.

We may transfer some of data subject's personal data to financial institutions and/or auditors and/or legal representatives to execute payments or take other actions in order to execute a contract or to be in accordance with the Law. Personal data including contact details of the data subject may also be processed with related entities of Aristion Academy.

Data subject rights:

Data subjects have the following rights:

- the right to access personal data and supplementary information
- the right to have inaccurate personal data rectified, or completed if it is incomplete
- the right to erasure (to be forgotten) in certain circumstances
- the right to restrict processing in certain circumstances
- the right to data portability, which allows the data subject to obtain and reuse your personal data for your own purposes across different services
- the right to object to processing in certain circumstances
